Dangerous Goods Ordinance, Cap. 295

Section 9B

Penalty for breach of licence

Notwithstanding any other liability which may arise under the provisions of this Ordinance or otherwise, the breach of any term or condition endorsed upon any licence issued pursuant to section 9 shall constitute an offence which shall be punishable on summary conviction— (Amended 4 of 2002 s. 6 and E.R. 5 of 2021)

(a) for a first offence, by a fine at level 5 and imprisonment not exceeding 1 month;

(b) for a subsequent offence, by a fine at level 6 and imprisonment not exceeding 3 months.

(Added 6 of 1994 s. 54. Amended 4 of 2002 s. 6 and E.R. 5 of 2021)



Dangerous Goods (Control) Regulation, Cap. 295G

Conditions of Store and Use Licence

- The conditions of store and use licence could be found in Section 98 of Cap. 295G.



CONDITIONS

- The licence or a copy of it must be displayed in a conspicuous place at the licensed store;
- The licence must be produced for inspection if requested by the Director;
- The licence must not be altered without the approval of the Director;
- The quantity for the storage and use of S2DG in aggregate must not exceed the maximum quantity for the storage and use in aggregate as specified in the licence;
- When the S2DG specified in the licence are not in use, they must be returned to the store for storage;
- The fire safety requirements issued for the store must be complied with at all times;
- Adequate measures must be taken to ensure the safe operation of the store, including the housekeeping, management, security, staff training, emergency preparedness and other control of the store;
- The layout and structure within the hazardous area of the store must be kept in the same way as shown in the latest plan of the store approved by the Director in writing;
- The store (including any fittings or equipment in it) must be maintained in good order and condition at all times;
- The store and all other areas in the hazardous area must be maintained in a clean and tidy condition;
- The store must not be used for the storage of any thing or dangerous goods (other than the S2DG specified in the licence), except—
 - any thing that is necessary to facilitate the storage of the S2DG; or
 - an empty receptacle used for containing the S2DG;
- If there is any ventilation opening provided in the store, the opening must not be obstructed;
- No vehicle may be parked in the hazardous area of the store for any purpose other than refueling;
- One way traffic flow must be maintained for the entry and exit routes for a store that is a refueling station;
- When a vehicle delivers fuel to the store, a safe emergency route must be maintained;
- S2DG must not be placed outside the store for any purpose or duration, unless the S2DG are in use or the placing of the goods is reasonably necessary in the course of handling the S2DG;
- The fire service installation or equipment for the store must be kept in efficient working order;
- The fire service installation or equipment for the store must—
 - be inspected by a registered contractor at least once in every 12 months; and
 - be certified, after the inspection, to be in efficient working order by a certificate issued by the registered contractor under regulation 9 of the Fire Service (Installations and Equipment) Regulations (Cap. 95 sub. leg. B);
- The fire service installation or equipment for the store must not be obstructed by any thing in a way that may affect its operation;
- If there is any incident of explosion or fire in, in the vicinity of or in connection with the store, or any leak of S2DG from the store—
 - the incident must be reported immediately to the Director; and
 - if loss of life or personal injury is caused by the incident—the loss or injury must also be reported immediately to the Director;
- Any spill or leakage of S2DG must be stemmed and handled promptly;
- If a licensed tank is inspected under regulation 8 of the Building (Oil Storage Installations) Regulations (Cap. 123 sub. leg. K) and, after the inspection, a certificate of inspection is issued under that regulation, a copy of the certificate must be delivered to the Director as soon as practicable.

- 總共貯存和使用 S2 危險品的分量不得超過該牌照指明的總共貯存和使用的最多分量；
- 在不使用該牌照指明的 S2 危險品時，須將它們送回該貯存所貯存；
- 須時刻遵守就該貯存所發出的有關消防安全規定；
- 須採取足夠措施以確保該貯存所的安全運作，包括該貯存所的整理、管理、保安、員工培訓、緊急情況的應變準備及其他控制事宜；
- 該貯存所的危險區內的布局及結構，須與消防處處長書面批准的該貯存所最新圖則所顯示的保持一致；
- 該貯存所(包括其內的任何裝置或設備)須時刻保持運作妥善及狀況良好；
- 該貯存所及該危險區內的所有其他地方須保持清潔整齊；
- 該貯存所除使用作貯存該牌照所指明的 S2 危險品外，不得使用作貯存任何東西或危險品(屬本條例第 2 條危險品的定義所指者)，但下述者除外—
 - 為利便貯存該 S2 危險品所需的任何東西；或
 - 使用作盛載該 S2 危險品的空容器；
- 如該貯存所設有任何通風口，該通風口不得被阻礙；
- 除為車輛加油外，不得為任何目的在該貯存所的危險區內停泊任何車輛；
- 如貯存所屬加油站，其出口及入口通道須維持單向通行；
- 當車輛輸送燃料至該貯存所時，須維持安全的緊急通道；
- 不論為任何目的或在任何期間，S2 危險品均不得放置在該貯存所外面，但如正在使用該 S2 危險品，或在處理該 S2 危險品過程中按理需要將其如此放置，則屬例外；
- 該貯存所的消防裝置或設備須保持有效操作狀態；
- 該貯存所的消防裝置或設備—
 - 須由註冊承辦商每 12 個月檢查最少一次；及
 - 在檢查後，須由註冊承辦商根據《消防(裝置及設備)規例》(第 95 章，附屬法例 B)第 9 條發出的證明書，證明該裝置或設備處於有效操作狀態；
- 該貯存所的消防裝置或設備不得被任何可影響其操作的東西阻礙；
- 如在該貯存所內或附近發生因爆炸或火警而造成的事故，或有因與該貯存所有關的爆炸或火警而造成的事故，或有 S2 危險品從該貯存所洩漏的事故—
 - 須立即將該事故向消防處處長報告；及
 - 如該事故造成任何人命損失或身體受傷——亦須立即將該人命損失或身體受傷向消防處處長報告；
- 如有 S2 危險品滲溢或洩漏，須迅速堵截和處理；
- 如根據《建築物(貯油裝置)規例》(第 123 章，附屬法例 K)第 8 條對任何持牌貯槽進行檢查，且在檢查後有檢查證明書根據該條發出，則須在切實可行範圍內盡快將該證明書的副本呈交消防處處長。

Section 98 (f) of Cap. 295G

Section 98 (h) of Cap. 295G

the layout and structure within the hazardous area of the store must be kept in the same way as shown in the latest plan of the store approved by the Director in writing;



Conditions of Store and Use Licence

Section 98 (t) of Cap. 295G

if there is any incident of explosion or fire in, in the vicinity of or in connection with the store, or any leak of S2DG from the store—

(i) the incident must be reported immediately to the Director; and

(ii) if loss of life or personal injury is caused by the incident—the loss or injury must also be reported immediately to the Director;



Dangerous Goods (Control) Regulation, Cap. 295G

Conditions of Conveyance Licence

- The conditions of conveyance licence could be found in Section 119 of Cap. 295G.



CONDITIONS

- The licence and the identification disc of the licensed vehicle must not be altered without the approval of the Director;
- The fire safety requirements issued for the vehicle must be complied with at all times;
- The vehicle (including any fittings or equipment in it) must be maintained in good order and condition at all times;
- Adequate measures must be taken to ensure the safe operation of the vehicle, including the housekeeping, management, security, staff training, emergency preparedness and other control of the vehicle;
- The fire service installation or equipment for the vehicle must be kept in efficient working order;
- The fire service installation or equipment for the vehicle must not be obstructed by any thing on the vehicle in a way that may affect its operation;
- The vehicle must not be used for the conveyance of any thing other than the S2DG (Class 2/3/3A) specified in the licence (permitted S2DG), except—
 - any thing that is necessary to facilitate the conveyance of permitted S2DG; or
 - an empty receptacle used for containing permitted S2DG;
- S2DG (Class 2/3/3A) must be carried in the cargo compartment of the vehicle;
- S2DG (Class 2/3/3A) must not be carried—
 - in a tank on the vehicle unless the tank is approved by the Director; or
 - in a tank-container on the vehicle unless the construction of the tank-container is in conformity with the IMDG Code;
- The vehicle must only convey S2DG (Class 2/3/3A) in the area specified in the licence;
- If the vehicle is a motor tractor, it must be operated together with a trailer that is a licensed vehicle;
- If the vehicle is a trailer, it must be operated together with a motor tractor that is a licensed vehicle;
- S2DG (Class 2/3/3A) in packaged form must be secured by suitable means that is capable of restraining the S2DG in the vehicle in a manner that prevents, during the conveyance process, any movement that would cause the S2DG packaging to be damaged or result in any accidental release of the S2DG;
- If there is any incident of explosion or fire in, in the vicinity of or in connection with the vehicle, or any leak of S2DG (Class 2/3/3A) from the vehicle—
 - the incident must be reported immediately to the Director; and
 - if loss of life or personal injury is caused by the incident—the loss or injury must also be reported immediately to the Director;
- Any spill or leakage of S2DG (Class 2/3/3A) must be stemmed and handled promptly.

 - 不得運載於該車輛上的液罐貨櫃內，除非該液罐貨櫃是遵照《規則》建造的；
- 該車輛只可在該牌照所指明的範圍內運送 S2 危險品(第 2/3/3A 類)；
- 如該車輛屬機動拖拉機，則須連同屬持牌車輛的拖車一起操作；
- 如該車輛屬拖車，則須連同屬持牌車輛的機動拖拉機一起操作；
- 有包裝的 S2 危險品(第 2/3/3A 類)須以能令該 S2 危險品以下述方式束縛在該車輛上的適當方法束縛；即以防止在運送過程中因移動而導致 S2 危險品包裝損壞或引致該 S2 危險品意外釋出的方式束縛；
- 如在該車輛上或附近發生因爆炸或火警而造成的事故，或有因與該車輛有關的爆炸或火警而造成的事故，或有 S2 危險品(第 2/3/3A 類)從該車輛洩漏的事故——
 - 須立即將該事故向消防處處長報告；及
 - 如該事故造成任何人命損失或身體受傷——亦須立即將該人命損失或身體受傷向消防處處長報告；
- 如有 S2 危險品(第 2/3/3A 類)濺溢或洩漏，須迅速堵截和處理。

Conditions of Conveyance Licence

Section 119 (g) of Cap. 295G

the vehicle must not be used for the conveyance of any thing other than the S2DG (Class 2/3/3A) specified in the licence (permitted S2DG), except—

- (i) any thing that is necessary to facilitate the conveyance of permitted S2DG; or*
- (ii) an empty receptacle used for containing permitted S2DG;*



Conditions of Conveyance Licence

Section 119 (n) of Cap. 295G

if there is any incident of explosion or fire in, in the vicinity of or in connection with the vehicle, or any leak of S2DG (Class 2/3/3A) from the vehicle—

(i)the incident must be reported immediately to the Director; and

Under Cap. 464

Timber store (木料倉) means any place used for the storage of timber other than –

- a) a place used for the storage of timber in bulk with an average sectional area of not less than 0.05 m^2
- b) a place used for storage of any timber in a quantity in the aggregate of less than 12 m^3
- c) a place used for the storage of any timber being a construction site within the meaning of regulation 2 of the Construction Site (Safety) Regulations (Cap. 59 sub. Leg. I)

1. Any person who on any occasion operates, keeps, manages or otherwise has control of a timber store in regard to the operation of which a licence is not in force commits an offence.

2. Where an offence under subsection (1) is alleged to have been committed, proof that a defendant did any act in connection with the operation, keeping, management or other control of a timber store is, in the absence of evidence to the contrary, proof that the defendant operated, kept managed or otherwise had control of a timber store.

3. It shall not be a defence that a person charged with an offence under subsection (1) did not know that the operation of the timber store which is the subject of the offence was not licensed.

4. Any person who commits an offence under subsection (1) shall be liable to a fine at level 5 and to imprisonment for 6 months.

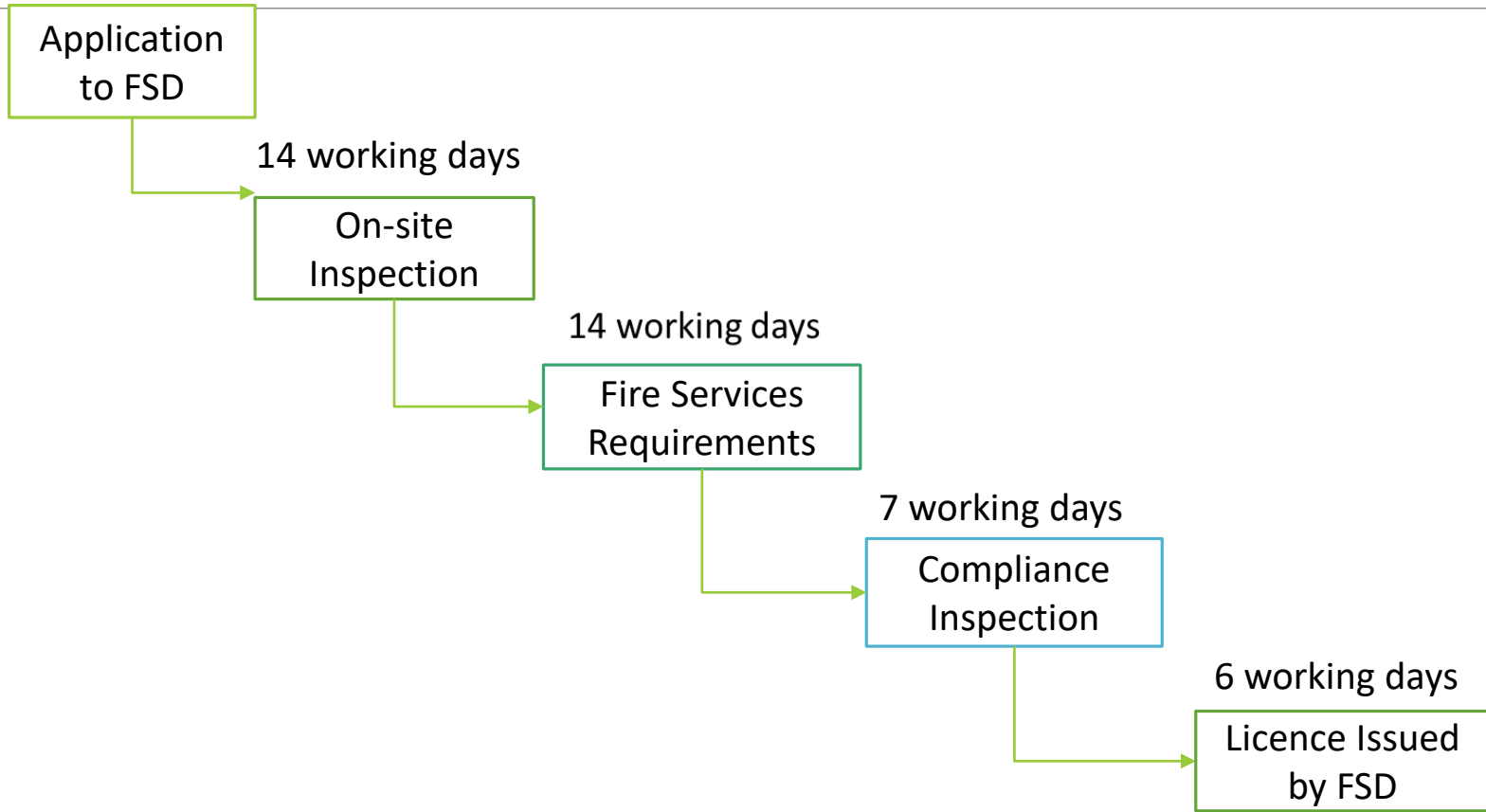


The Director shall not grant a licence unless he is satisfied, in relation to the proposed operation of a timber store, that-

- a) the applicant will adequately and personally supervise the operation of the timber store;
- b) the place of proposed operation is-
 1. Suitable for the operation of a timber store

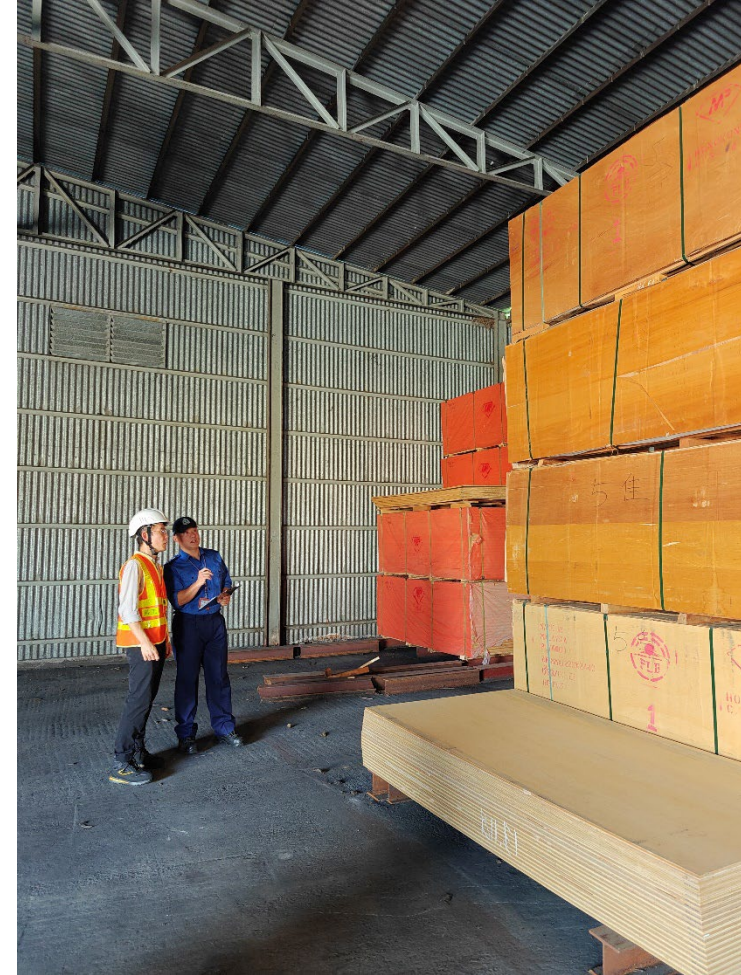

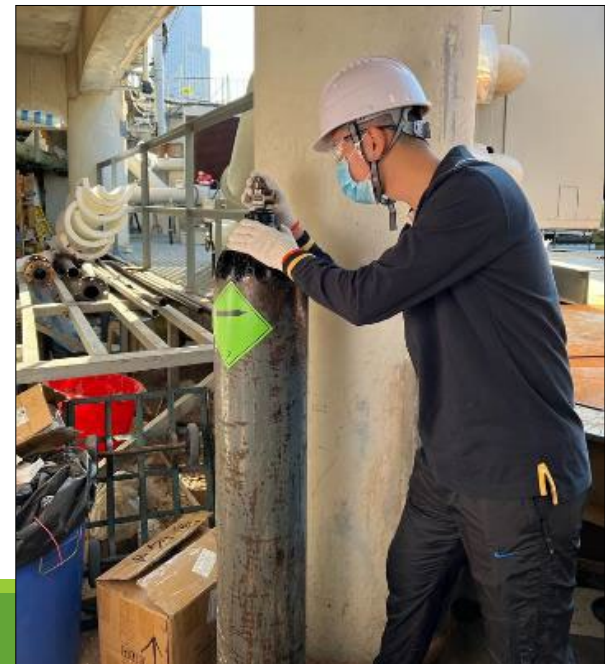
